Dear Plan Member:

Enclosed is a notice from the Health Benefits Trust announcing that the Aetna Preferred Provider (PPO) network is replacing the Beech Street PPO network. This change is effective for all medical claims incurred on or after March 1, 2014. **IMPORTANT – Alaska Regional Hospital and Mat-Su Regional Medical Center will continue to be the PPO providers within the Municipality of Anchorage and Mat-Su Valley for inpatient and outpatient services. Chugach Physical Therapy, Ascension Physical Therapy, Alaska Hand Rehabilitation and the Coalition Health Center will also continue to be PPO providers within the Municipality of Anchorage.**

**The notice also announces that effective March 1, 2014, Aetna will replace Qualis for all inpatient hospital preauthorization, utilization review, discharge planning, case management and preauthorization of certain outpatient procedures. Please also note the changes to the preauthorization requirements.**

Below is a **copy** of the **NEW** ASEA/AFSCME Local 52 Health Benefits Trust member ID card. You will now be assigned two member ID numbers. You will find both ID numbers at the top of this notice. These ID numbers will appear on the permanent cards mailed around March 10<sup>th</sup>. Please pay close attention to the instructions and present this letter to your medical provider if you need to seek medical care before you receive your new ID cards. The ID card provides important information about the Plan’s preferred provider networks, claim submission information, preauthorization requirements and contact information. - 1) The **Aetna member ID** number should be used when your provider submits medical claims to Aetna and dental claims to the ASEA Health Benefits Trust, or when you submit medical reimbursement requests to the Trust.
- 2) The **ASEA member ID** number should be used when purchasing prescriptions, using your vision benefits, submitting prescription claims to Caremark or vision claims to VSP and when contacting Alere about the Disease Management Program and Ceridian about your Employee Assistance Program (EAP).
